The Inspection Officer, Deputy Educational officer Dy.E.O, has caused inspection and submitted his/her report in the reference cited.

After Careful examination of the proposals from the society and also the inspection report of the Inspecting Officer in the reference cited permission is hereby accorded for Opening/Upgrading the educational institutions with classes (8-8) for 2024-2025 academic year in subject to the following conditions.

- That the society shall abide to the rules and regulations made in the Government order fourth cited above.
- That the Society shall provide the necessary amenities like accommodation, sanitary facilities, drinking water facilities, furniture, library, laboratory equipment play field required staff as per the staff pattern and other facilities are necessary, before approaching the competent authority.
- That the society shall apply for recognition by 31st August at the latest duly fulfilling the condition.
- That the permission accorded is restricted to present year only and it is not valid for the subsequent academic year.
- That the permission does not confer any right on the society for claiming recognition.
- That the permission is accorded to Sri Adichunchanagiri Mahasamsthana math R society and no other society or body can open a school on their behalf.
- The permission is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
- The society shall provide the necessary material even if it costs more than the deposit amount.
- Following the NEP norms as per reference 5th read above.


