WHEREAS the Author of this Trust, who after being blessed by his Predecessor late Jagadguru Sree Sree Sree Ramanandhanatha Swamigalu received the orders of investiture as 71st Peetadhipathi in the year 1974, has been in charge of the funds and properties of this charitable and religious institution, rendering the service to the public;

WHEREAS the Previous Peetadhipathis, apart from dedicating their lives to the innumerable activities in social, educational and other charitable aspects of life, founded schools, boarding homes etc., spending huge amount of funds and thus left their names and aims unvanishing and laid down the traditions to manage properties and funds of the Mutt in Trust; and

NOW THIS INSTRUMENT OF TRUST WITNESSETH AS FOLLOWS:

1. The name and style of the Trust shall be SREE ADHICHUNCHANAGIRI MAHASAMSTHANA MUTT.
2. The place of Office of the Trust shall be at ADHICHUNCHANAGIRI, CHUNCHANA HALLI P.O., NAGAMANGALA TALUK, MANDYA DISTRICT, KARNATAKA STATE.
3. The Objects of the Trust shall be:-
  - (a) To establish institutions in the field of training of medicine and nursing, farming, commerce, arts, science, technology etc.
  - (b) To undertake the diffusion of medical knowledge among poor and neglected people.

(3) The objects of the Trust shall be:-

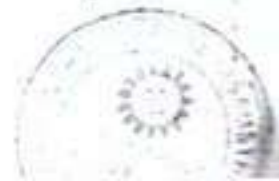
- (c) To establish free Hostels for the deserving boys and girls to facilitate them for their education and finding way of life.
- (d) To open, establish and run schools, colleges, other educational institutions and to establish University for the benefit of people irrespective of caste creed or colour.
- (e) To continue to maintain the high traditions and to continue to maintain the Gaduges in such traditional manner being followed by this institution.
- (f) To give free assistance to various institutions working in the country for the upliftment of poor and handicapped children, without any bar.
- (g) To assist any institution to serve the aim to awaken a sense of love and responsibility in our fellowmen towards suffering and destitute children and juveniles in any part of the country thereby to ease their distress.
- (h) To open, establish, run and continue a research institution in Science, Agriculture, Commerce, Technology and Philosophy and to disseminate the fruitful results to the public.
- (i) To open, run and maintain free boarding hostels for students and to infuse in them a taste and zeal for healthy and standard education.
- (j) To encourage and to grant Scholarships and other like financial assistance to deserving students.

(3) The objects of the Trust shall be:-

(k) To build, and maintain community Halls and Kalyana Mantapas for the use of general public irrespective of caste, creed and colour. The Community Halls or Kalyana Mantapas let out to the general public shall be charged at nominal rates to cover the maintenance and other expenses relating to the Community Halls and Kalyana Mantapas.

(l) To assist the management of the school and colleges, Orphanages, Hostels etc.

(m) To establish and maintain libraries and reading rooms.

(n) To assist any institution formed for charitable purposes which are recognised under Section 80-G of the Income-tax Act, 1961.

TRUST FUNDS AND PROPERTIES

The funds and other monies held by this Mutt as Trust Funds and the properties and assets already held by this Mutt by the Author of this Trust as a Trustee of the institution shall continue to be the Funds, properties and assets of the Trust.

Donations, contributions and the proceeds of the property, if any sold, shall be credited to the Trust Fund.

ADMINISTRATION OF THE TRUST

The Author of the Trust, Sree Sree Sree JAGADGURU BALAGANGADHARANIATHA SHANIGALU shall be the sole Trustee of this Trust and after him, his successors who will be chosen to the Post according to the customs and traditions prevailing in this institution, shall be the sole Trustee of this Trust with the same power of the management as the Author himself holds.

The Author of this Trust, to achieve the objects of this Trust effectively and systematically, may appoint a Managing Committee and such power of appointing Managing Committee shall vest with the successor Pentadhipathis also who will succeed to the Peeta of Sri Adhichunchanagiri Mahasamsthana Mutt. The sole Trustee shall nominate such number of persons, as he deems fit, as the members of the Managing Committee and the members so appointed shall hold the office at the pleasure of the sole Trustee.



The sole Trustee may also <sup>manage or manage with</sup> ~~constitute~~ <sup>(constitute)</sup> regional or local committee or committees to manage the affairs of this Trust and its branches founded or to be founded at such other place or places other than the Registered Office and may delegate such powers as deemed necessary by the sole Trustee, and the sole Trustee shall nominate such number of persons, as he deems fit, as the members of each regional and local committee or committees.

The members of the regional or local committee or committees so appointed shall hold the office at the pleasure of the sole Trustee.

The sole Trustee can withdraw all or any of the powers vested with managing committee, regional or local committee or committees and other staff members in the best interests of the Trust.

The administration of the different centres shall be managed by the local or regional committee or committees subject to the superintendence, direction and control of the sole Trustee.

The rules governing the management of the various centres shall be framed by the local or regional Committee or committees, as the case may be, and duly approved by the sole Trustee.

The Author hereby declares that the Trust is irrevocable and all the income received by the Trust under these presents as well as the corpus of any money received by them, where the corpus is permitted by the donors to be and applied, shall always be applied for and in furtherance of the objects of the Trust.

The sole Trustee or any person while discharging his duties, in the best interest of the Trust, shall not be liable for any loss to the Trust Estate, unless the Trustee or such person is guilty of fraud or misappropriation of Trust Funds.

POWERS OF THE SOLE TRUSTEE

The sole Trustee shall exclusively discharge the objects of the Trust without interference from anybody and shall have absolute power to purchase, dispose and manage the properties in the best interest of the Trust.

The sole Trustee shall have special powers to revise the terms of this Trust Deed and thereby to add, delete or substitute any of the clauses of this Trust Deed in the best interest of carrying out the objects of the Trust. But no addition, deletion or substitution shall be made which may prove to be repugnant to the provisions of Section 80-G/2(15) of the Income-tax Act, 1961.

The sole Trustee shall have the power to appoint the employees to carry out the objects of the Trust and he shall also have the power to dismiss any employee or employees without assigning any reasons, in the best interest of the Trust.

The sole Trustee shall cause the accounts of this Trust to be maintained and audited yearly by a qualified person.

The accounting year will be from 1st day of July to 30th day of June

DUTIES AND POWERS OF THE TRUSTEE

(a) To carry out the objects of the Trust.

(b) To invest Trust Funds in Trust Securities.

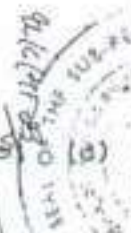

DUTIES AND POWERS OF THE TRUST.

- (c) To maintain regular accounts in respect of receipts and payments of the Trust and to get it audited annually by a qualified person duly appointed by the Trustee.
- (d) To sell all or any of the investments at any time and permit the proceeds of such sale whether income or capital to be applied in furthering the object or the objects of the Trust herein above mentioned.
- (e) To recover, collect and receive the interest and income of the Trust Fund and pay out all costs, charges, and expenses properly incurred for such recovery and collections and hold the balance of interest and income hereinafter referred to, upon Trust, to use and apply the net income for all or any other charitable objects herein above mentioned and where such income is insufficient to carry out the objects of the Trust, the Trustee may use such portion of the corpus of the Trust Fund as may be deemed necessary.
- (f) The Trustee shall have the power to borrow money on the security of the Trust property for the furtherance of the objects of Trust and to alienate the Trust property for necessary purpose relating to the Trust only.
- (g) The Trustee shall be at liberty to receive donations from Joint Stock Companies, firms, associations of persons and individuals and shall hold the same as part of the Trust Fund, and to use and apply the same for all or any of the charitable purposes mentioned hereinabove.
- (h) The Trustee shall have power to open and operate, jointly or severally, upon the banking accounts of the Trust as may be decided upon from time to time and to employ persons to carry out the work and to appoint Auditors on such remuneration and on such terms as he think fit.
